



Voluntary Waiver and Release Agreement

I ASSUME ALL RISKS AND DANGERS KNOWN OR UNKNOWN, FORESEEN OR UNFORESEEN, INCIDENTAL TO THE SPORT OF FIGURE SKATING AND ALL ACTIVITIES I MAY PERFORM ON AN ICE SURFACE, ASSOCIATED WITH MY PARTICIPATION IN THE EVENT AND HEREBY RELEASE AND HOLD HARMLESS THE ORGANIZERS AND THEIR RESPECTIVE SUCCESSORS AND ASSIGNS, FROM AND AGAINST ANY AND ALL CLAIMS, DAMAGES, LIABILITIES, COSTS AND EXPENSES, INCLUDING REASONABLE ATTORNEYS' FEES, ARISING OUT OF MY PARTICIPATION IN THE EVENT, INCLUDING WITHOUT LIMITATION ANY PERSONAL INJURIES OR DAMAGE TO MY PROPERTY WHICH I MAY INCUR AS A RESULT OF THOSE DANGERS INHERENT IN PERFORMING ON AN ICE SURFACE.

If any provision of this waiver and release shall for any reason be held invalid or unenforceable, such invalidity or unenforceability shall not affect any other provision hereof and this waiver and release shall be construed as if such invalid or unenforceable provision were omitted.
